

BACKGROUND

Reinsurance is an industry with limited visibility. Yet reinsurance companies play a critical role in global risk management. They are specialists in assessing and assuming, for example, catastrophe, liability, and financial risks and emerging perils such as cyber risk. They are also leading experts in managing risk data. At the same time, reinsurers face major challenges such as climate change, pandemics, digitalization, and a dynamic capital and financial world.

The CAS in Reinsurance Management offers a comprehensive overview of the current developments in the reinsurance industry and its environment, provides the latest scientific methods and knowledge, and covers cutting-edge topics with the help of proven industry experts.


Graduates benefit from:

TARGET GROUP

The CAS in Reinsurance Management is aimed at professionals from the insurance and reinsurance industries who have a degree from a university, university of applied sciences, or technical college (or another recognized professional qualification) and three to five years of relevant industry experience.



Structure and Content

How to make relevant knowledge work for you

We provide you with the basic principles, methods, and tools to meet the challenges facing the reinsurance industry today.

FOCUS

The focus in Module 1 (Management in Reinsurance) is on business models and leadership, business lines and clients. Module 2 (Risk and Technology in Reinsurance) addresses risk and capital, technologies, and innovation. Participants play a simulation game lasting several days. The aim is to increase participants' professional, analytical, and problem-solving competence and their ability to reflect and make decisions.

INSTRUCTORS

The program is taught by senior lecturers at the ZHAW School of Management and Law, supported by leading ex-

perts in primary and reinsurance, established market researchers, and consultants. Together, they ensure that participants benefit from state-of-the-art knowledge in the respective fields and that the curriculum reflects new developments and current market events.

ADVISORY BOARD

An advisory board has been formed to ensure program quality, consistency, relevance, and professionalism and oversee program updates. It consists of academics and industry experts, including reinsurance executives.

ADMISSION REQUIREMENTS

We welcome applications from graduates of technical colleges or universities (of applied sciences) with at least three years of professional experience. Professionals without a university degree may also qualify. They need to have three to five years of professional experience and either a related continuing education certificate from a higher technical college or have passed a recognized higher technical examination (höhere Fachschule or höhere Fachprüfung mit eidgenössischem Fachausweis/Diplom). The final admission decision is made by the Head of Program.

WORKLOAD

Participants completing the program successfully will be awarded 12 ECTS (European Credit Transfer System) credits. One ECTS credit corresponds to a workload of 25–30 hours. The entire program requires 300 – 400 hours of study.

PERFORMANCE ASSESSMENTS

Participants must complete a written performance assessment for each module to obtain the certificate. In addition, they must complete a group assignment. The above workload estimate includes exam preparation and the group assignment.

LOCATION

Classes take place on the ZHAW School of Management and Law campus in Winterthur, a few minutes from the main railway station. A three-day seminar may be held in Germany at a location relevant to the reinsurance industry (e.g., Munich or Cologne). >>> www.zhaw.ch/sml/campus

LENGTH OF PROGRAM

This program is a part-time course of study offered over a period of three months.

CLASS SCHEDULE

Classroom and online instructions are offered in five teaching blocks of two to three days each (Thursday, Friday, and Saturday).

LANGUAGE OF INSTRUCTION

The program is taught in English.

QUALIFICATION

Participants are awarded a "Certificate of Advanced Studies in Reinsurance Management" by the ZHAW School of Management and Law, provided they complete the program, pass the performance assessments, and meet the compulsory attendance requirement of at least 80 percent for both modules.

COSTS

The program fee is CHF 9,500 per person and includes all course materials. Travel expenses are excluded.
