Information on Dispensation from Modules / Module Exemption

- Requests for dispensation must be submitted on time even if not all documents (e.g., evidence of grades achieved) required can be supplied yet.
- Grades or assessments from other universities will not be transferred.
- Achievements that have already been credited (e.g., for direct entry into the main study period) will not be credited twice.
- Only modules you have passed will be considered in a request for dispensation.
- For modules from which you have been exempted you will only be credited with the corresponding ECTS credits.
- Modules from which you have been exempted will not appear in your transcript of records.
- Modules from which you have been exempted will be listed in your first-year (Assessment) and degree certificates, but they will have no effect on your grade point average and will not be taken into account in calculating your final grades.
- Once submitted, requests for dispensation cannot be withdrawn.
- Students receive a credit transfer agreement via E-Mail which lists all modules from which they have been exempted. A signed copy must be submitted to the Student Services via E-Mail.
- > Students who have been exempted from a module must not attend classes, nor are they entitled to write the end-of-module exam.
- Requests for dispensation for the fall semester must be submitted no later than the **end of calendar week 33**, those for the spring semester no later than the **end of calendar week 3**. Late or incomplete requests will not be considered.
- If your request for dispensation has been rejected, you can request an appealable decree (*rekursfähige Verfügung*). In such a case, please contact Student Services (<u>studentservices.sml@zhaw.ch</u>).
